Alcoholic Beverage Application

_____ I, the undersigned applicant, being a person of good moral character and a citizen of the United States, hereby make this application for a license to engage in the sale of beer and wine in the City of Baldwin, State of Georgia, and, under oath, make all the following statements, supply all information, and furnish all certificates, affidavits, bonds and other supporting data as required thereby.

_____ I, the undersigned applicant, understand that a statement must be attached to this application stating whether I, or any other person with an interest in the application, has made an application at any previous time for any alcoholic beverage and the disposition of such application.

_____ I, the undersigned applicant, have never had a previous license revoked by any state or subdivision thereof, or by federal government.

_____ I, the undersigned applicant, understand that a statement must be attached to this application listing persons interested directly or indirectly in profits or losses, or both, of the proposed business.

_____ I, the undersigned applicant, understand that, if such application is for retail purposes, then the proposed retail outlet, which is located at the above-stated address, must be in compliance with paragraph 7 of the Ordinance governing the sale of beer and wine within the City of Baldwin. Further, I, the undersigned applicant, understand that I will be required, at my own expense, to provide proof of compliance with this provision to the City Council at the time this application is made. Such proof may include a floor plan of the establishment in question.

_____ I, the undersigned applicant, understand that this application shall be accompanied by lawful money of the United States, or by a certified check or cashier's check, payable to the City of Baldwin for the proper amount of the license fee, together with a separate check in the amount of the administrative fees in order to defray investigation and administrative costs.

_____ I, the undersigned applicant, shall be responsible for the management and operation of the business for which the license is granted. Further, I, the undersigned applicant, understand that a complete statement of my financial condition must be submitted with this application.

_____ I, the undersigned applicant, understand that, if such application is for retail purposes, then the proposed retail outlet, which is located at the above-stated address, must be in compliance with paragraph 11 of Section 1-9 and Section 1-27 of the Ordinance governing the sale of beer and wine within the City of Baldwin. Further, I, the undersigned applicant, understand that I will be required, at my own expense, to provide proof of compliance with this provision to the City Council at the time this application is made. Such proof may include a written statement from a Registered Land Surveyor.

_____ I, the undersigned applicant, understand that all licenses shall be effective during the remainder of the calendar year in which it is issued and all renewals shall be effective from January first through December thirty-first of each calendar year. All applications for renewal shall be made in accordance to paragraph 9 of Section 1-9 of the Ordinance governing the sale of beer and wine within the City of Baldwin.

_____ I, the undersigned applicant, understand that a violation of any of the provisions of the City Ordinance governing the sale of beer and wine within the City of Baldwin, a violation of any regulation of the City of Baldwin, or a violation of any law or regulation of the state of Georgia, pertaining to the sale of beer or wine, by myself, or my agents or employees, shall subject my license to suspension or revocation as the City Council deems proper.
