## **City of Baldwin Yard Sale Rules & Regulations**

1. Applicants must display a copy of the yard sale permit on site during the entirety of the yard sale.
2. No more than four (4) yard sales can be held at any location during any calendar year. If members of more than one household join in a single yard sale, then all participants will be considered to have held a yard sale.
3. Personal property offered for sale must be contained within the resident's yard, garage, driveway, patio, or other structure on the resident's property. Items for sale may NOT be displayed in the public right of way.
4. Signs or other forms of advertisement for the yard sale cannot be placed more than four (4) days prior to the sale.
5. All signs or other forms of advertising must be removed within twenty-four (24) hours after the end of the yard sale. All debris and trash resulting from the sale must also be cleaned up within twenty-four (24) hours).
6. All vehicle parking must be done in compliance with all applicable laws and ordinances. Baldwin Police Department may enforce temporary controls as necessary to alleviate or prevent hazards and/or traffic created by any yard sale.

***Any other issues/concerns will be handled on a case-by-case basis by either the City Clerk or the Chief Administrative Officer.***
